Yearly Recap from Your Board President – Sam Packer



The 2020 pandemic did not significantly affect LFCA finances. We did end the year with a slight increase in dues delinquencies to 2.5% vs a usual 1.5%. We also added a Zoom subscription to our account to support the annual and monthly board meetings. Trees along the trails were also again a major expense, totaling \$9,500. In 2020, we made reserve expenditures of \$23,150.00 for trails repair and \$600.00 for replacement water hydrants at two entrances. The use of reserves keeps the dues steady and avoids the need for special assessments. Annual dues for 2021 remain \$125.00, the same as for 2020. We do not charge for seller documents or to confirm dues amounts and payments for the many sales and refinances that occurred in 2020. As in past years, the LFCA will begin 2021 in a strong financial condition with healthy reserves.

My Back Yard Dave Wilson – Board Member

When Mary and I bought our home on Cervantes Lane in 1982, the walking paths were unpaved. The view from our our deck was a wonderful mix of forest, homes, and lawns. Up near the top of hill from our house was a split rail fence that the builder had put up behind his model home on Fishermans Lane to draw attention to the trail. There was a lot of mountain laurel growing wild along the trails as well and blueberry bushes.



Our trails are paved now through the good work of the homeowners association. The trails have been a godsend to our many neighbor families as they get in their daily walk through our woods. Watch for the delicate white blossoms of the mountain laurel next spring, as well as those of the service berry, blueberry and perhaps some indian pipestem mushrooms.

We spend a great portion of the association annual budget on trails, trees, storm water management, and common ground maintenance. Keeping the forest healthy, beautiful and accessible is a major responsibility that is taken very seriously.

We have a wonderful community and with both you and mother nature working together, we can keep it that way!
