# **Yearly Recap from Your LFCA President** – Sam Packer

To our new neighbors – Welcome to Lake Forest! For all in our community, I hope 2020 is a good year for everyone. I am happy to report we are keeping up with the HOA finances (annual dues are expected by April 1st); our common property continues to be well managed, and your all-volunteer Board Members strive to respond to your questions as quickly as possible. Plans for our community this year include a focus on the trails. Each year a small segment gets repaired or replaced. Currently the trail contract is being worked and should be agreed upon by late Spring.

One thing you may see is more discussion about drainage through our neighborhood. The parkway has storm drains through our area that were created for the old parkway size. Yes, the parkway is being expanded – possibly to 3 lanes each way by our development and that is causing concern for us due to less natural buffer and more storm impact. #### IN THE NEWS

Glass Recycling - To improve the quality of single-stream recycling, Fairfax County no longer accepts glass bottles and jars in curbside recycling bins (effective 10/1/19). Options for glass disposal: deliver to purple glass receptacles or dispose in regular trash. **Yard Waste** - Yard waste for recycling is only picked up March 1 thru December 24. Per Virginia Code, it is illegal to dump trash, garbage, refuse, or litter on any public property or private property. Private property includes our HOA common land.

**Road maintenance** – Virginia Department of Transportation (VDOT) is responsible for the maintenance and snow removal of our roads. For online VDOT snow plow tracking view <a href="http://vdotplows.org/">http://vdotplows.org/</a>.

## **Financial Report \$\$\$\$\$ - Wes Cox**

LFCA continues to be in a strong financial condition with healthy reserves. Annual dues for 2020 remain \$125.00, the same as 2019. Trees and grounds care combined represented 78% of the total expenditures in 2019, and each item came in under budget. In particular, cutting of dead trees came to only \$7500.00 (\$8000.00 was budgeted). In 2018, trees had cost \$14,300.00. No reserve expenditures were made in 2019, allowing the reserves to grow at the pace projected in the 2018 reserve study (about 38% of dues). These reserves have enabled LFCA to maintain a relatively steady annual dues rate. As a result of the 2019 experience, the Board has chosen to adopt the same budget for 2020. Also in 2020, the Board plans to use some of the reserve money to rebuild additional trails.

My Back Yard - Dave Wilson



While walking in our wooded common grounds, I came across a watercourse created by storm water run-off. What had once been a three- or four-foot ditch when the community was built in 1980 is now an 8-foot wide, 5 or 6-foot-deep steep sided channel. Clearly jumping down into it would be hazardous, scrambling up the other side nearly impossible for me. Lake Forest has many of these deeply eroded runs.

What is now SR-286, the Fairfax County Parkway, was once Pohick Road, a narrow two-lane country road. The Parkway increased the amount of paved roadbed by 300%, but there were no changes to the storm water runoff drainage system in our community. Mother Nature made the adjustments for us, turning little steam beds into roaring rivers when it rains. Fairfax County will soon begin work widening the Parkway. This could mean more rain water run-off, more trees dying with roots exposed by erosion, more damage to neighboring community common grounds.

VDOT and Fairfax County Board of Supervisors are focused on highway improvement. It is important for all residents to stay informed and raise their concerns.
